Collection Notice Statement - General Enquiries (Indi Properties)

The Indi properties are managed by a group of companies including Essence Communities Pty Ltd (ACN 639543740) and its related bodies corporate (collectively, **Essence**) as agents of the property owners, being entities within the Investa group (**Owners**).

Essence is committed to protecting the privacy of individuals and their personal information (as defined in the *Privacy Act 1988* (Cth) (**Australian Privacy Act**) or the New Zealand Privacy Act 2020 (**NZ Privacy Act**), together the **Privacy Law**, in respect of individuals within Australia or New Zealand, as the case may be) or personal data (as defined in the *General Data Protection Regulation* (**GDPR**) in respect of individuals in the EU).

Please read this carefully as it will have important consequences for you in relation to the collection, use and disclosure of your personal information or personal data provided to Essence.

You understand that:

- 2. Essence will collect your personal information or personal data directly from you (including any unsolicited information or data you may provide in the body of your enquiry, application or otherwise).
- 3. In certain circumstances, Essence may be required to collect personal information or personal data from third parties, depending on the nature of your enquiry or application. By submitting your application as part of the leasing process, you authorise, and agree to provide any necessary authorisation to, your current and/or previous landlord(s), letting agent(s) and/or employer(s) to release all your information to Essence for reference checking purposes.
- 4. The purposes of Essence collecting and using your personal information or personal data includes but is not limited to:

 - c. our third party service providers (including, without limitation, payment processing providers, and providers of IT, caretaker, cleaning, security, maintenance and utilities services);
 - d. law enforcement, or medical or health service providers that are required to assist you in the case of a medical or public health emergency;
 - e. third parties who assist us with the marketing process and any other organisation set out in our Privacy Policy;
 - f. your current and/or previous landlord(s), letting agent(s) and/or employer(s) for the purposes of conducting a reference check and verifying your employment and residential letting history; and
 - g. other disclosures as required by law or as permitted by the Privacy Act.
- 7. It is possible that some of the information collected may be disclosed to Essence's related bodies corporate or service providers outside of Australia or New Zealand, as the case may be, which may include United States of America and United Kingdom. You consent to your information being disclosed to a destination outside Australia or New Zealand (whichever applies) for this purpose, and you understand and acknowledge that either the Australian Privacy Principle 8.1 or the NZ Privacy Act will not apply to such disclosures of your personal information or personal data outside of the relevant jurisdiction.
